Regulations on Applying for the Establishment of Enterprises in Taipei Port Free Trade Zone

Promulgated on Sep. 2, 2005 in accordance with Kee-Gang-Tze-Mao-Tze No. 0940018013 Amended on Sep.15, 2006 in accordance with Kee-Gang-Tze-Mao-Tze No. 0950017384 Amended on Oct.18, 2006 in accordance with Kee-Gang-Tze-Mao-Tze No. 0950018624

- 1. These regulations are enacted by Keelung Barbor Bureau (hereinafter referred to as this Bureau) in accordance with Articles 5, 10, 11 and 22 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by Ministry of Transportation and Communications.
- 2. The terms "Free Trade Zone enterprise" in these regulations refers to an incorporated company that satisfies Subparagraph 2, Article 3 of the Act for the Establishment and Management of Free Trade Zones; and has been approved for trading, warehousing, logistics, collecting and distributing (cargo of) containers, transiting, transshipment, forwarding, customs clearance, assembling, sorting, packaging, repairing and fabricating, processing, manufacturing, displaying, or technological service in the Free Trade Zone.
- 3. Taipei Port Free Trade Zone extends from No.1, No.2 and No. 3 bulk cargo centers, the vehicles and logistic center and the temporary oil storage center etc., totally 79 hectares.
- 4. After Sept.20, 2005, the initial applicants, who want to operate Free Trade Zone enterprises within the Free Trade Zone, should be entitled to put forward an application for establishment after this Bureau approves that there is an agreement of cooperative building, an agreement of lease equipment and operation, or other agreement between both sides. Subleasing to a third Free Trade Zone enterprise is allowed only after this Bureau approves the sub-lessee.
- 5. Initial applicants, who wish to operate a Free Trade Zone enterprise within the Free Trade Zone, should provide ten applications and all relevant documents pertaining to the same to this Bureau in accordance with Article 5 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by the Ministry of Transportation and Communications.

The application form mentioned in the previous paragraph is available in Appendix I. The flow chart of applications is available in Appendix IV.

- 6. This Bureau must organize an examination group to deal with applications to start a Free Trade Zone enterprise within the Free Trade Zone. The official concerned shall firstly examine the application and documents and inform the applicant to remedy any deficiencies within 30 days if such application and documents show any.
- 7. This Bureau shall investigate the application for an operating license according to the nature of the Free Trade Zone enterprise to be established, together with the responsible organizations and Customs, in accordance with Article 10 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by the Ministry of Transportation and Communications. Those eligible will be granted an operating license. An example of the operating license mentioned in the previous paragraph is available in Appendix III.
- 8. Applicants, who have already started businesses in the Free Trade Zone before Sept. 30, 2004

and want to start another Free Trade Zone enterprise in the Zone, shall provide ten applications for an operating license and all relevant documents pertaining to the same to this Bureau in accordance with Article 11 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by the Ministry of Transportation and Communications.

The application form mentioned in the previous paragraph is available in Appendix II. The flow chart of applications is available in Appendix IV.

9. This Bureau shall investigate applications for operating licenses from enterprises that have already started businesses in the Free Trade Zone according to the nature of the Free Trade Zone enterprise to be established, together with the responsible organizations and Customs, in accordance with Article 10 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by the Ministry of Transportation and Communications. Those eligible will be granted operating licenses.

An example of the operating license mentioned in the previous paragraph is available in Appendix III.

10. Operating licenses will be invalidated in accordance with related procedures if the Free Trade Zone enterprises are affected by Articles 19 and 20 of the Regulations Governing the Operation and Management of Enterprises within Free Trade Zones Administered by the Ministry of Transportation and Communications.
